In response to the COVID-19 pandemic, Congress passed the American Rescue Plan Act (ARPA), and it was subsequently signed by the President of the United States. Colleges and universities which received emergency grants from this legislation are required to periodically report on the items listed below in bold print. Faulkner University's responses are listed immediately below each requirement.

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the ARPA program to provide Emergency Financial Aid Grants to students.

University agreed to be bound by the conditions set forth in that agreement by drawing down the grant funds. The University had previously signed and submitted the Recipient's Funding Certification and Agreement under HEERF I for both the Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act, as well as the Institutional Portion of the Higher Education Emergency Relief Fund Formula Grants Authorized by Section 18004(a)(1) of the CARES Act. The certification and agreement for the Emergency Financial Aid Grants to Students and the Institutional Portion for the CARES Act were signed and submitted to the Department of Education, via grants.gov, on April 21, 2020 and April 22, 2020, respectively.

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under ARPA.

The Student Aid portion allocated to Faulkner University under ARP section 2003(a)(1) of ARPA was \$3,903,628.

Cumulative Student Aid funds under HEERF I, II, and III

The cumulative Student Aid portions allocated to Faulkner University under HEERF I, II, and III totaled \$6,326,606.

3. The total amount of Emergency Financial Aid Grants distributed to students under the ARPA program as of the date of submission (i.e., as of the initial report and every calendar quarter thereafter).

Phase 1 - July 2021

Faulkner University disbursed \$742,100 in Emergency Financial Aid Grants to students under ARPA in July 2021.

Phase 2 - September 2021

Faulkner University disbursed \$1,656,840 in Emergency Financial Aid Grants to students under ARPA in September 2021.

As of September 30, 2021, a total of \$2,398,940 has been disbursed in Emergency Financial Aid Grants to students under ARPA.

Faulkner University disbursed \$1,200 in an Emergency Financial Aid Grant under ARPA in October 2021.

As of December 31, 2021, a total of \$2,400,140 has been disbursed in Emergency Financial Aid Grants to students under ARPA.

Cumulative Emergency Financial Aid Grants disbursed under HEERF I, II, and III As of December 31, 2021, a total of \$4,825,679 has been disbursed in Emergency Financial Aid Grants to students under HEERF I, II, and III.

Phase 3 - March 2022

Faulkner University disbursed \$1,503,495 in Emergency Financial Aid Grants to students under ARPA in March 2022.

As of March 31, 2022, a total of \$3,903,635 has been disbursed in Emergency Financial Aid Grants to students under ARPA.

Cumulative Emergency Financial Aid Grants disbursed under HEERF I, II, and III

As of March 31, 2022, a total of \$6,329,174 has been disbursed in Emergency Financial Aid Grants to students under HEERF I, II, and III.

Phase 1 - July 2021

Faulkner University estimates that 1,693 students at the institution were eligible to receive Emergency Financial Aid Grants under the ARPA program.

Phase 2 - September 2021

Faulkner University estimates that 2,816 students at the institution were eligible to receive Emergency Financial Aid Grants under the ARPA program.

As of September 30, 2021, Faulkner University estimates that 3,195 individual students were eligible to receive Emergency Financial Aid Grants under the ARPA program. Some were eligible for grants in both the summer and fall semesters.

As of December 31, 2021, Faulkner University estimates that 4,102 unduplicated students were eligible to receive Emergency Financial Aid Grants under HEERF I, II, and III.

As of March 31, 2022, Faulkner University estimates that 3,508 individual students were eligible to receive Emergency Financial Aid Grants under the ARPA program. Some students were eligible for grants in more than one semester.

Cumulative estimated number of students eligible to receive Emergency Financial Aid Grants under HEERF I, II, and III

As of March 31, 2022, Faulkner University estimates that 4,664 unduplicated students were eligible to receive Emergency Financial Aid Grants under HEERF I, II, and III.

5. The total number of students who have received an Emergency Financial Aid Grant under ARPA.

Phase 1 - July 2021

A total of 957 students received Emergency Financial Aid Grants under ARPA at Faulkner University in July 2021.

Phase 2 - September 2021

A total of 1,590 students received Emergency Financial Aid Grants under ARPA at Faulkner University in September 2021.

As of September 30, 2021, a total of 1,906 individual students have received Emergency Financial Aid Grants under ARPA. Some students received awards in both the summer and fall semesters.

One student received an Emergency Financial Aid Grant under ARPA at Faulkner University in October 2021.

As of December 31, 2021, a total of 1,907 individual students have received Emergency Financial Aid Grants under ARPA. Some students received awards in both the summer and fall semesters.

As of December 31, 2021, a total of 2,940 unduplicated students have received Emergency Financial Aid Grants under HEERF I, II, and III.

As of March 31, 2022, a total of 2,185 individual students have received Emergency Financial Aid Grants under ARPA. Some students received grants in more than one semester.

Cumulative number of students who received an Emergency Financial Aid Grant under HEERF I, II, and III

As of March 31, 2022, a total of 3,181 unduplicated students have received Emergency Financial Aid Grants under HEERF I, II, and III.

6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under ARPA.

Phase 1 - July 2021

To satisfy requirements for an Emergency Financial Aid Grant under the ARPA program at Faulkner University, a student is required, at minimum, to meet the following criteria:

- Must have been enrolled in the Summer 2021 semester for at least one class as of July 7, 2021
- Students who withdrew from all classes not included
- Must have a 2020-2021 FAFSA on file in the Financial Aid Office with an EFC of 5711 or lower

A total of 957 students were determined to have met the requirements to receive a grant. Once the list of eligible students was completed, a matrix was designed to determine the dollar amount an eligible student would receive. The student's EFC was used, along with enrollment status (full time, three quarter time, half time, or less than half time), to determine the grant amount for each student. The higher the need, based on EFC, the greater the award. Grants ranged from \$1,000 for students enrolled full time with the highest need down to \$100 for students enrolled less than half time with the lowest need. The matrix utilized is provided below.

Phase 2 - September 2021

To satisfy requirements for an Emergency Financial Aid Grant under the ARPA program at Faulkner University, a student is required, at minimum, to meet the following criteria:

- Must have been enrolled in the Fall 2021 semester for at least one class as of September 13, 2021
- Students who withdrew from all classes not included
- Must have a 2020-2021 FAFSA on file in the Financial Aid Office with an EFC of 8000 or lower
- International and undocumented students included and provided grants as if they had an EFC of 8000

A total of 1,590 students were determined to have met the requirements to receive a grant in Phase 2. Once the list of eligible students was completed, a matrix was designed to determine the dollar amount an eligible student would receive. The student's EFC was used, along with enrollment status (full-time, three quarter time, half-time, or less than half-time), to determine the grant amount for each student. The higher the need, based on EFC, the greater the award. Grants ranged from \$1,200 for students enrolled full- time with the highest need down to \$120 for students enrolled less than half-time with the lowest need. The matrix utilized is provided below.

In October 2021, it was determined that one additional student had met the requirements to receive a grant in Phase 2 bringing the total to 1,591 for Phase 2.

Phase 3 - March 2022

To satisfy requirements for an Emergency Financial Aid Grant under the ARPA program at Faulkner University, a student is required, at minimum, to meet the following criteria:

- Must have been enrolled in the Spring 2022 semester for at least one class as of March 22, 2022
- Students who withdrew from all classes not included
- Must have a 2020-2021 FAFSA on file in the Financial Aid Office with an EFC of 8000 or lower

 International and undocumented students included and provided grants as if they had an EFC of 8000

A total of 1,539 students were determined to have met the requirements to receive a grant in Phase 3, however, one eligible student declined the funds leaving 1,538. Once the list of eligible students was completed, a matrix was designed to determine the dollar amount each student would receive. The student's EFC was used, along with enrollment status (full-time, three quarter time, half- time, or less than half-time), to determine the grant amount for each student. The higher the need, based on EFC, the greater the award. Grants ranged from \$1,175 for students enrolled full-time with the highest need down to \$130 for students enrolled less than half-time with the lowest need. The matrix utilized is provided below.
