Faulkner University Graduate Counseling has been in continuous operation since admitting its first class in the fall of 2010. Faulkner has two programs: Clinical Mental Health Counseling and School Counseling, both of which can lead to licensure as a Professional Counselor and Certified School Counselor respectfully. Together these programs exist to fulfill our mission which states:

The graduate program bridges traditional academia with practical experiences for a well-rounded education that explores various areas of counseling and mental health while integrating Christian principles to the profession. Courses are designed to develop your counseling skills through a variety of classes and collaborative classroom and field experiences. Curriculum has been developed to meet the state and national regulatory criteria, leading to licensure and certification of professional counselors. Graduates of Faulkner's Master of Science in Clinical Mental Health Counseling program are prepared to work in a variety of clinical settings, including community agencies, state agencies, churches, and Christian ministries.

Program Objectives

1. Students will demonstrate an understanding of the professional roles, responsibilities, and the ethical practice of the counselor.
2. Students will develop the skills, knowledge, and cultural sensitivity to work within a diverse society, including engagement in social justice and advocacy.
3. Students will apply their understanding of an individual's biological, social, and psychological development as a foundation of clinical practice.
4. Students will identify a variety of factors that contribute to client well-being and guide clients in their exploration of career development.
5. Students will integrate their knowledge of counseling theories and their ability to build rapport and develop a therapeutic alliance.
6. Students will demonstrate their understanding of the group process, as well as effective therapist characteristics.
7. Student will apply their knowledge of selecting, administering, and interpreting effective assessments.
8. Students will evaluate the efficacy of research relevant to the practice of clinical counseling.
9. Student will demonstrate the knowledge and skills needed to provide treatment for a broad range of mental health issues in a variety of settings.
10. Students will demonstrate their ability to ethically integrate spirituality in counseling.

For the spring, summer and fall semesters of 2024, Faulkner University had 15 graduates from the Clinical Mental Health Counseling program. As of January 2025, 13 graduates are presently working in the field and 8 of those graduates have their associate/provisional license and are currently under supervision. Two of the graduates are currently awaiting state board approval to award their ALC and begin the supervision process and one is applying in the next cycle. Two students did not respond to questions about their employment and/or licensure.

National Counselors Exam (NCE)

As of January 2025, no graduates from 2024 have reported taken the National Counselor Exam.

Evaluation Reports and Modifications

After a review of our data for each KPI in our program, as well as a review of our aggregate data, our faculty met to discuss implementing changes, as needed, to our evaluation process. These changes focused on areas where our KPIs fell below the 80% threshold or where the faculty reasoned that communication of expectations could be improved. Efforts to implement changes showed significant improvement in our students meeting the KPI expectations from 2022 and 2023. Below is a list of those KPIs that fell below 80%, or that the faculty thought could be improved and the program modification implemented.

- *Spring 2024 and Fall 2024*
Area 9: Clinical Mental Health Counseling
KPI 2: COU 6355 Crisis Memoir Analysis Rubric (Item 8)
80% of students will score 2-competent or higher on item 8 of the Crisis Memoir Analysis Rubric

Finding: 50% (3 of 6) students scored less than 2 on the rubric item. Two students scored a 0 and one student scored a 1 in Spring 2024. 60% (2 of 5) students scored less than 2 on the rubric item. One student scored a 0 and one student scored a 1 in Fall 2024

Modification: This assignment and KPI were also noted in the 2022 Annual Report as falling below the 80% expected threshold. At that time changes were made to make the rubric expectation less broad and more detailed by adding to the assignment description. The KPI also fell below the 80% expected threshold in Spring and Fall semesters of 2023. In reviewing the assignment and KPI the Core Faculty have determined that the KPI is still an important measure for our program. The Core Faculty will further discuss strategies for improving student performance for the KPI at the upcoming Spring 2025 mid-term meeting.

- *Fall 2024*
Area 5: Counseling and Helping Relationship
KPI 1: COU 6340 Analysis of the Helping Relationship Term Paper Rubric (Item 5)
80% of students will score 3-competent or above on item 5-Person of the Therapist on the 6340 Analysis of the Helping Relationship Final Research Paper Rubric.

Finding: 25% (1 of 4) students scored a 3 on the rubric item. Three students scored a 1.

Modification: In review of this KPI it was noted that the three students who scored a 1 on the rubric item were also students who had scored lower on other KPI's and assignments and had already been discussed for possible remediation. The Core Faculty will make remediation determinations at their upcoming Spring 2025 mid-term meeting.

- COU 6695 Internship in Counseling

For the Spring, Summer and Fall semesters of 2024 the faculty noted that several students had not completed the Internship course in one semester, with some students taking two to three semesters. Though no specific modification has been adopted, the faculty is in

discussions about how to better help students complete their internship experience in a timely manner and will further discuss strategies to measure the standard, objective and KPI at the upcoming Spring 2025 mid-term meeting.
