Full-time employees are eligible to receive a 70% tuition discount on most programs.

Children and stepchildren of full-time employees are eligible to receive institutional scholarships/grants covering at least 60% of tuition in the traditional undergraduate program (Montgomery campus only).

Full-time employees may designate up to two (2) family members or friends to receive a 50% tuition discount on eligible programs.

Graduates of Knoxville Christian School may receive scholarships/grants covering at least 50% of tuition in the traditional undergraduate program (Montgomery campus only).

Parents and step-parents of Knoxville Christian School students may receive a 50% tuition discount on eligible programs.
