So if completers of Faulkner University's M.Ed. School Counseling Program are able to obtain either a current, valid out-of-state School Counselor K-12 credential OR have an official at Faulkner University sign an Institutional Recommendation Form verifying completion of a state-approved and CAEP-approved School Counselor K-12 certification program in the last 2 years, then the completers of the Faulkner program WILL qualify for Idaho School Counselor certification.
