


## **ONLINE REGISTRATION PROCEDURES**

Online registration for Fall 2016 will be available Monday, April 11 through Thursday, April 14, 2016. Current 2L students (rising 3Ls) will register on Monday and Tuesday; current 1L students (rising 2Ls) will register on Wednesday and Thursday. Registration will be open 8:30 a.m. to 5:00 p.m. each day. If you cannot arrange to participate in online registration during this period, please contact the Law Registrar, Jennifer K. Johnson, at (334) 386-7213 or by email at <u>ikjohnson@faulkner.edu</u>. To audit a course, please contact Mrs. Johnson before registeringfor the course.


1. Go to <u>http://my.faulkner.edu</u> and enter your "Login ID" (Student ID Number) and password.



2. When you log in, you will be directed to the online registration portal. Confirm that the term selected is "2016 Fall."



- Click "Select Classes" and choose your Fall 2016 courses from the list. (Remember that 10-16 hours is full-time in the spring, and you must get permission before attempting to register for more than 16 hours.) Then click on "Continue" to proceed with registration.
- 4. Federal reporting regulations require that Faulkner collect data on the housing arrangements of each student. Please make the housing selection that most closely describes your living situation during the upcoming academic year. Click "**Finish**" to proceed to the next step.



5. This will bring you to the "**View Summary**" page. The Law Registrar, Jennifer K. Johnson, will be listed as your academic advisor. Please confirm that your class schedule is correct. Click "**Continue**" to proceed with registration completion.



**IMPORTANT:** Your registration and financial aid requirements are not complete until you have <u>both</u> entered your name and clicked "**Accept**".






