Parking Decals are required for all vehicles parking on the Faulkner campus. Parking Decals are free to students. Please go to the Faulkner App to register your vehicle and apply for a decal. In the app, click on the Links button and then Student Parking Decal Request Form. Completion and submission of the form will allow the student to stop by the Campus Safety & Police Department office the following business day to pick up their decal.

Faulkner University Police Officers patrol the Montgomery campus 24 hours every day of the year. Officers are available for calls, escorts to vehicles, and to provide information as needed.

## **Parking Information**

Parking space is limited on the Montgomery campus and Residence Students are asked to walk whenever possible.

Parking for Resident Students is provided near Residence Halls. Please make use of marked parking spaces in paved parking areas. Overflow parking can be found nearby in paved and non-paved parking areas.

Parking for Non-Resident Students is provided near business and classroom buildings.

Striped areas in paved parking lots are not designated parking spaces. These areas are marked for emergency operations and to protect student vehicles from damage. It is important that fire trucks can maneuver through our parking lots.

Student Parking is not allowed in any parking space reserved for specific persons, handicapped, visitors, or faculty and staff.

Faulkner Law students should park at the rear of the Law School building.

## **Traffic Information**

The speed limit on campus is 15 MPH.

Please come to a complete stop at Stop Signs and yield to oncoming traffic.

Please yield to all pedestrian traffic. There are many people walking around campus and we need to make sure they are safe.

Traffic accidents should be reported to the Faulkner University Police Department – 334-239-5496.

All city and state traffic laws are adopted and enforced on campus. Please drive carefully and:

No texting while driving  
Wear your seat belt  
All passengers must be safely seated  
Yield to emergency vehicles

## **Parking & Traffic Tickets**

Parking and traffic violations may result in disciplinary sanctions by the Dean of Students, up to \$100 fine, and suspension of vehicle privileges on campus.

The most often violations cited are:

Speeding  
Parking in Handicapped parking  
Parking in Restricted/Reserved space  
No parking decal displayed  
Failure to stop at a Stop Sign  
Improper Parking  
Parking in Emergency Vehicle zone

## **Sojourner Park**

Sojourner Park is reserved as a campground for approved RV parking. Our guests pay for this area and live in this area for extended periods during the year.

Students are not allowed to park in this area. This area may be used as a tailgate/VIP parking area during stadium events, but a parking permit for this area is required.
